The remaining bank loans carried fixed interest rate at 1.53% to 2.53% (31 December 2013: 6.0%) per annum."

The Board wishes to clarify that due to inadvertent clerical error, the bank loans carrying floating interest rates should be approximately <u>HK\$75,000,000</u> (instead of approximately <u>HK\$112,500,000</u>) and the effective interest rates should be <u>6.15%</u> (instead of ranging from <u>6% to 6.15%</u>) per annum, whereas the remaining bank loans carried fixed interest rate should be at 1.53% to <u>6%</u> (instead of at 1.53% to <u>2.53%</u>).
